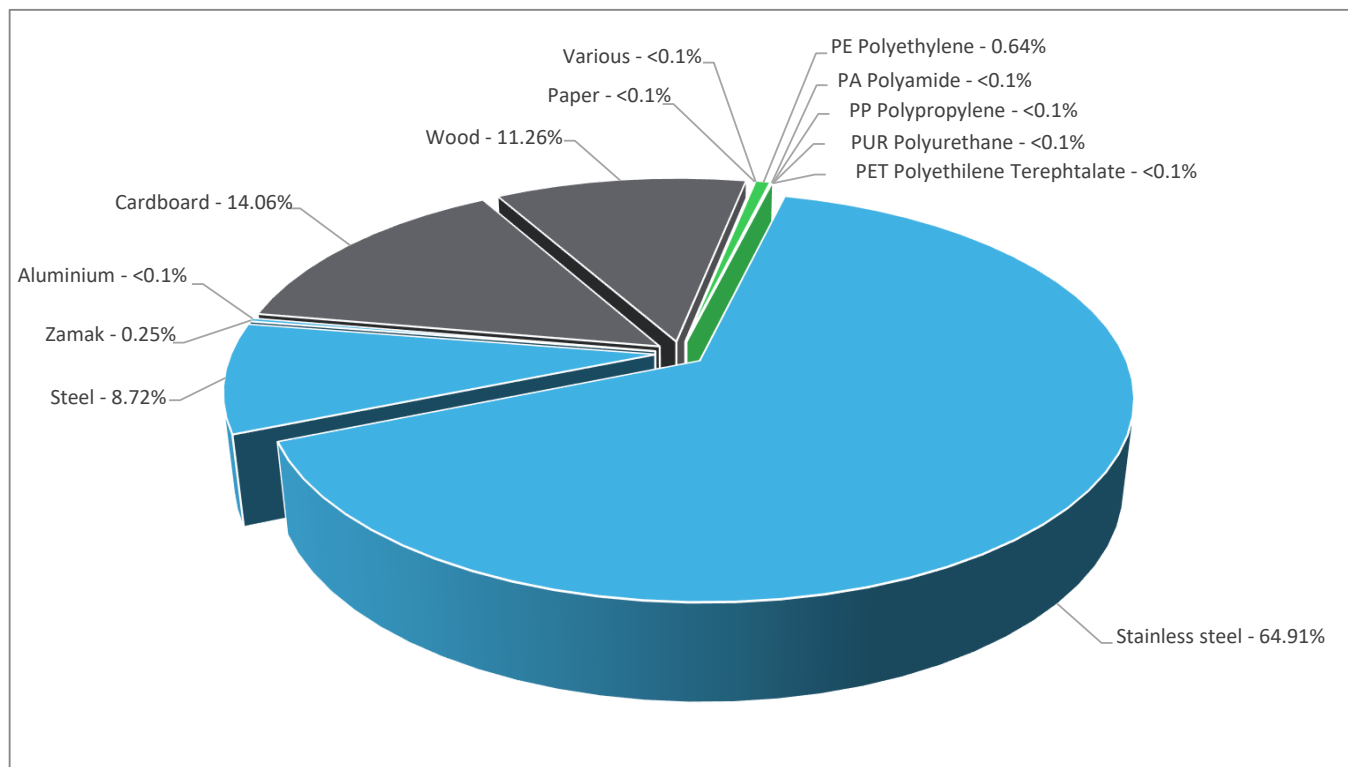
General information

Description of the product	Spacial SMX - Stainless steel Enclosures protect the inside installed equipment against the external environment, where cleanliness is required or for highly corrosive environments and protect people against accidental contact with internal electrical devices.
Functional unit	Protect persons during 20 years against direct contact with live parts and allow grouping monitoring, control and protection devices in a single enclosure with dimensions 1800mm x 800mm x 400mm, while protecting against mechanical impacts (IK10 conforming to IEC 62262) and the penetration of solid objects and liquids (IP66 conforming to IEC 60529).

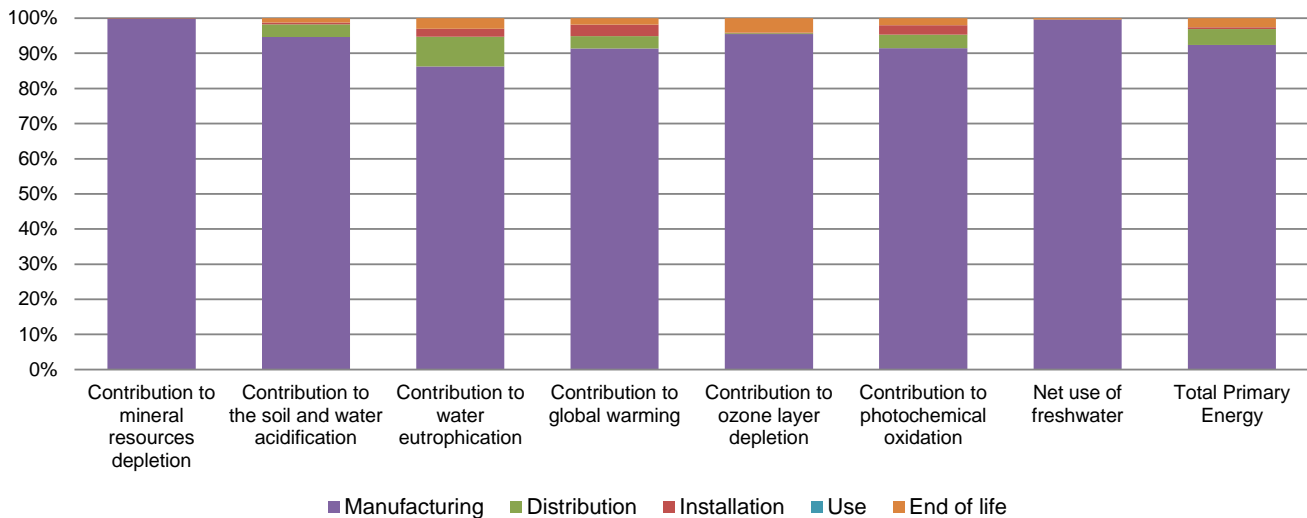
