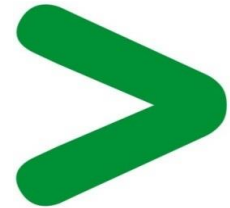

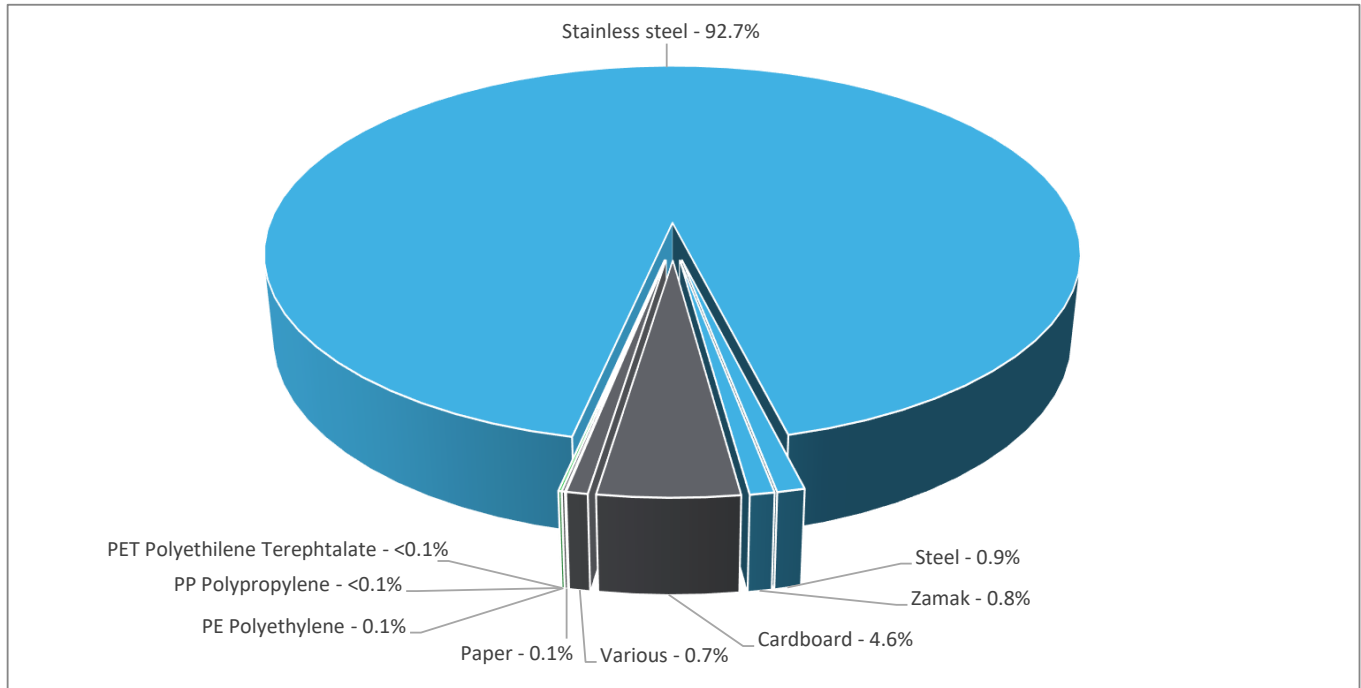
## General information

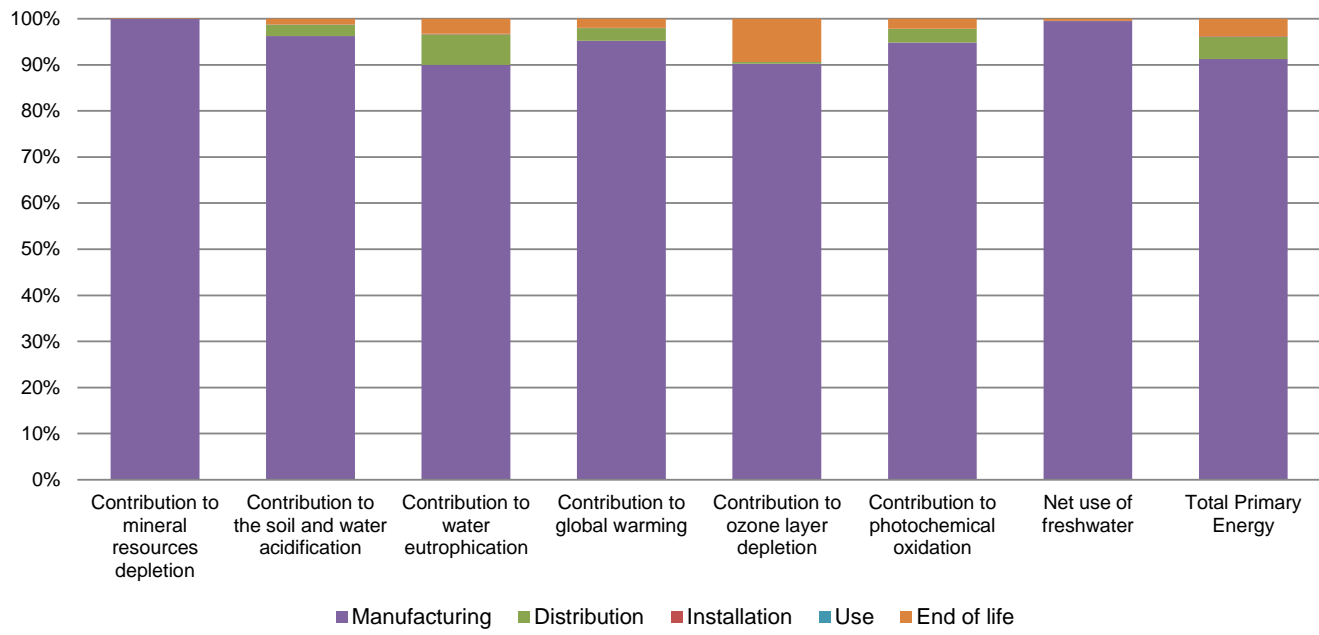
