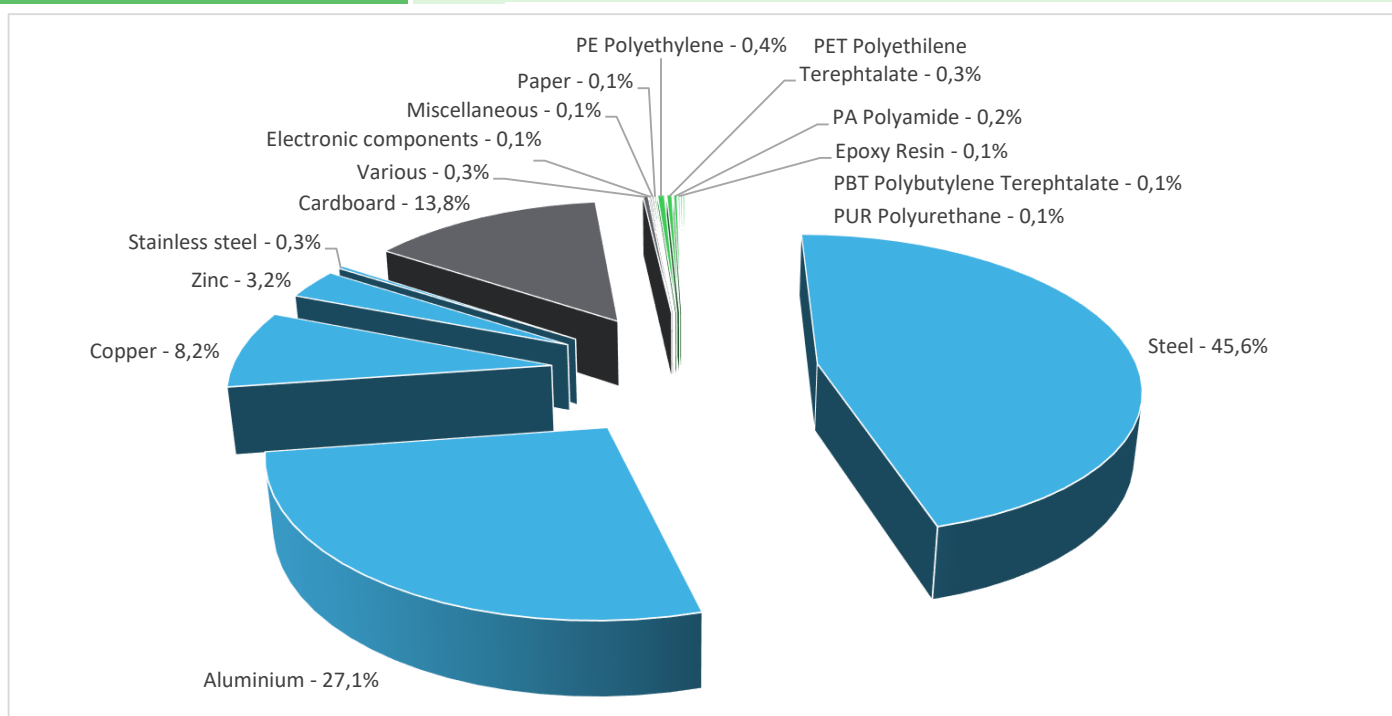

Products of this range are designed in conformity with the requirements of the RoHS directive (European Directive 2011/65/EU of 2 January 2013, amended in March 2015, 2015/863/EU and in November 2017, 2017/2102/EU) and do not contain, or only contain in the authorised proportions, lead, mercury, cadmium, hexavalent chromium or flame retardants (polybrominated biphenyls - PBB, polybrominated diphenyl ethers - PBDE), Bis (2-ethylhexyl)phthalate - DEHP, Benzyl butyl phthalate- BBP, Dibutyl phthalate - DBP, Diisobutyl phthalate - DIBP) as mentioned in the Directive.

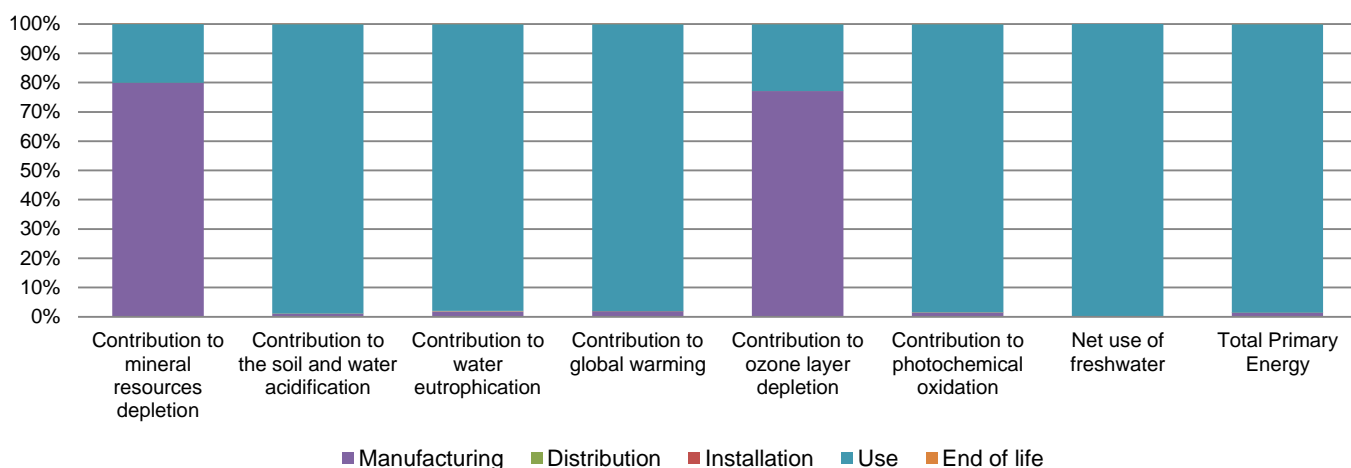

The use phase is the life cycle phase which has the greatest impact on the majority of environmental indicators (based on compulsory indicators).

According to this environmental analysis, proportionality rules may be used to evaluate the impacts of other products of this range.

Depending on the impact analysis, the environmental indicators (without "contribution to Mineral Resources Depletion" and "contribution to ozone layer depletion") of other products in this family may be proportional extrapolated by energy consumption values. For mineral Resources Depletion, 80% is caused by manufacturing and 20% is caused by the use phase therefore 80% of the impact may be proportional extrapolated by mass of the product and 20% may be proportional extrapolated by energy consumption values. For ozone layer depletion, 77% is caused by manufacturing and 33% is caused by the use phase therefore 77% of the impact may be proportional extrapolated by mass of the product and 33% may be proportional extrapolated by energy consumption values.

Please note that the values given above are only valid within the context specified and cannot be used directly to draw up the environmental assessment of an installation.
