Radio Equipment Directive (FuAG) Compliance

Important information

From **28 December 2024** onwards, the Radio Equipment Directive (RED, *German: FuAG*) applies to all **new product listings** on Conrad Marketplace of any country we operate in. To comply with the law, it is **mandatory** to **provide the technical information** explained below. Germany's FuAG implements EU Directive 2022/2380 and stipulates the information you will need to provide.



Compliance with the Radio Equipment Directive (RED/FuAG)


The RED both ensures the safety and electromagnetic compatibility of radio equipment and enables an efficient use of the radio frequency spectrum.

Product labelling is one of the new stipulations of the RED. From now on, product detail pages (PDPs) must display pictograms that specify the type of charger included in the purchase. The RED/FuAG governs the exact design of these pictograms (see below).
