SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general	: Call a physician immediately. Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves.

4.3. Indication of any immediate medical attention and special treatment needed

SECTION 5: Firefighting measures
