##### Inhalation

**6.2. Environmental precautions** Avoid release to the environment. Inform appropriate managerial or supervisory personnel of all environmental releases. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

**6.3. Methods and material for containment and cleaning up** Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. ## 8.2. Exposure controls

### **Appropriate engineering controls**

Good general ventilation should be used. Ventilation rates should be matched to conditions. 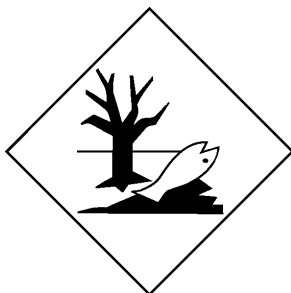
