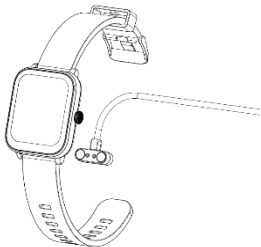

Make sure the charging pins on the charging cable fit correctly onto the charging contacts at the back of your Smartwatch, then connect the other end to a power source. Make sure to fully charge the watch before first use. It will take approximately 3 hours to fully charge.

How to pair and disconnect watch

1. Open the “Denver Smart Life Plus” app and set your profile. Then tap “Connect to Smartwatch” in settings and choose your smartwatch “SWG-155” to connect.
2. To disconnect your smartwatch, please go to the app settings and tap “Disconnect Smartwatch”. For iPhone, you also need go to “Bluetooth” in your iPhone Settings to “Forget This Device”.
