Le bouton WPS (Configuration Wi-Fi protégée) est une solution rapide et simple d'établir une connexion sans fil sécurisée entre votre caméra réseau et votre routeur/point d'accès sans fil.

1. Maintenez enfoncé le bouton WPS sur votre **routeur/point d'accès sans fil** pendant la durée nécessaire à l'activation de la fonction WPS.

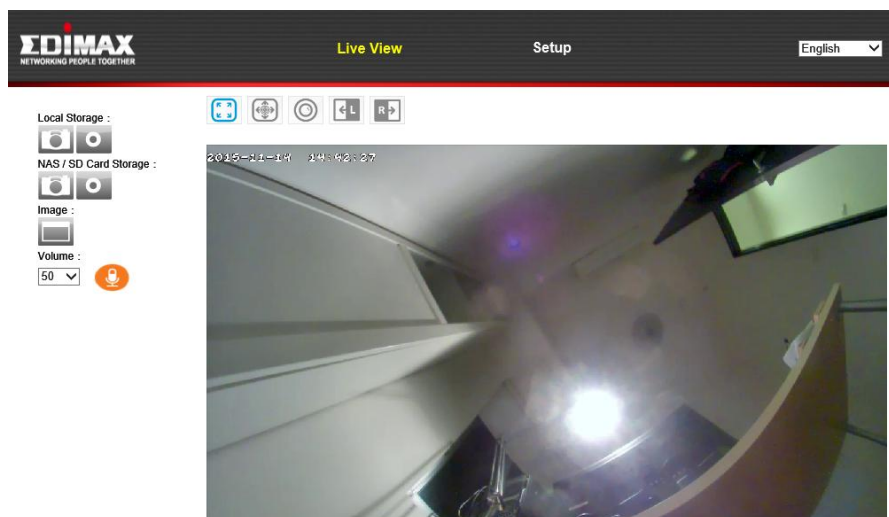
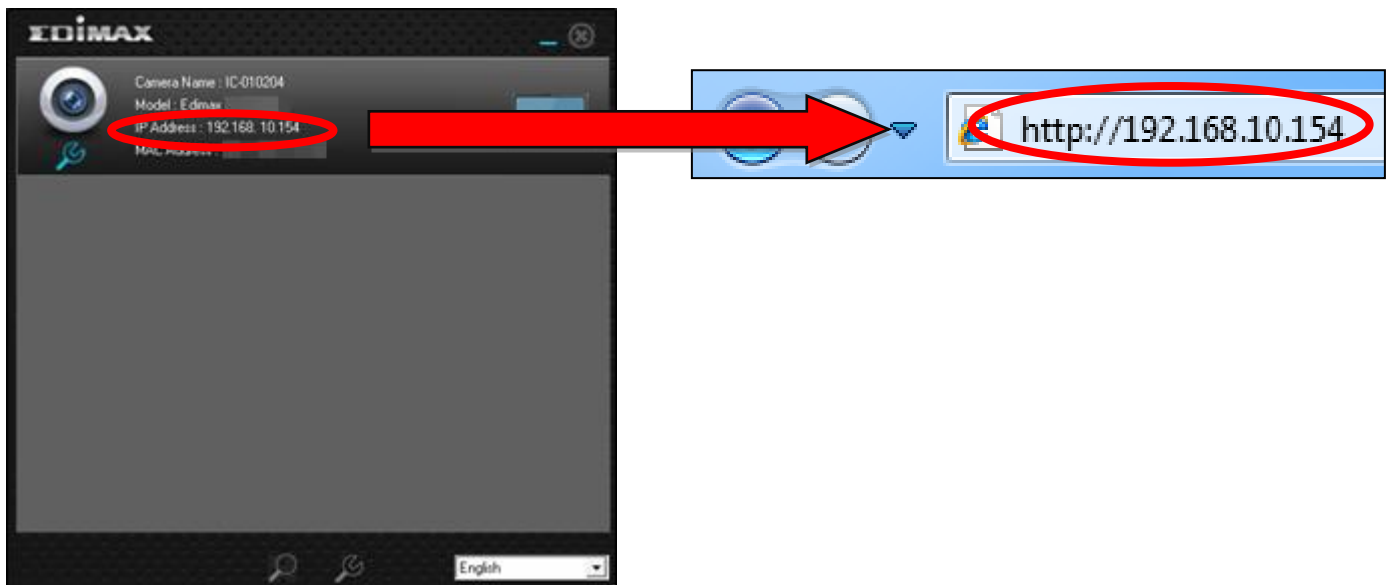

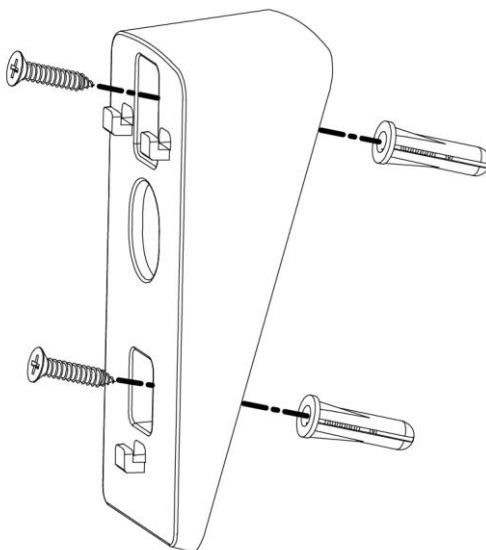


## Fixation murale

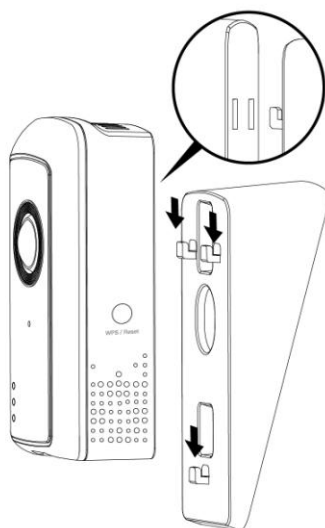

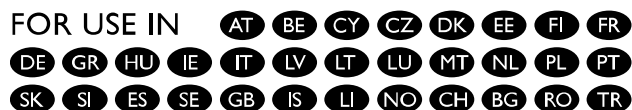
