#### I-4. Termékcímke

A kamera hátoldalán található címke tartalmazza a hálózati kamera MAC-címét, felhőazonosítóját és beállító SSID-jét.

 **A könnyebb azonosíthatóság érdekében a MAC-cím és a felhőazonosító megegyezik.**

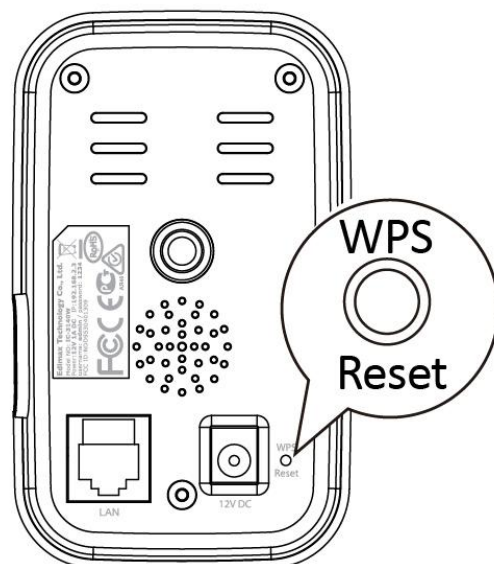
A felhőazonosító lehetővé teszi, hogy hálózati kamerájának élőképet bármilyen aktív internetkapcsolattal rendelkező eszközről, távolról is megtekintse (a részletes leírást lásd a **III-4. fejezetben**). **Myedimax.com**.



#### I-5. Visszaállítás

Ha hálózati kamerájával problémát tapasztal, visszaállíthatja annak gyári beállításait. Ekkor **minden** beállítás visszaáll a gyári alapértékre.

- 1.** Nyomja le és tartsa lenyomva legalább 10 másodpercig a hátoldalon található WPS/Reset gombot.
- 2.** Engedje el a gombot, amikor az áramellátást jelző **zöld** LED **gyorsan villog**.
- 3.** Várja meg, amíg a hálózati kamera újraindul. A kamera akkor áll készen, amikor az áramellátást jelző **zöld** LED **lassan villog**.



**Beállítás után az áramellátást jelző **zöld** LED folyamatos fénye jelzi, hogy a kamera sikeresen kapcsolódik a felhő kiszolgálóhoz.**

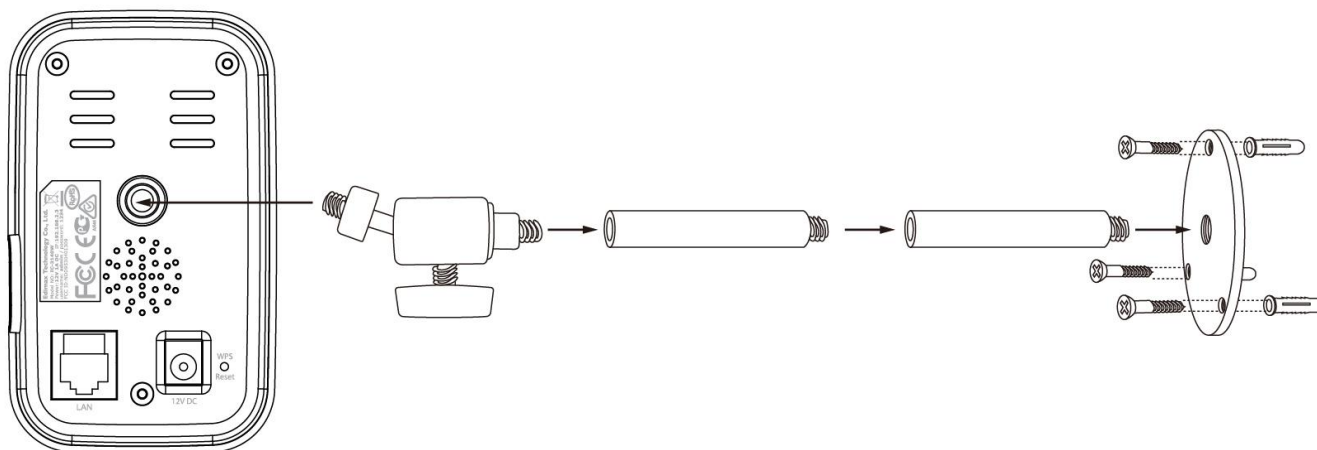
## II. Hardver telepítése

---

### II-1. Szerelőkészlet

A csomag tartalmaz egy állványt a hálózati kamerához. Az állvány némi szerelést igényel.

1. A kameraállványt az alábbi ábra szerint szerelje össze. A kameraállvány saját lábán is állhat, vagy falra is szerelhető:



2. A kamera hátulján lévő szerelőfurat felhasználásával rögzítse a hálózati kamerát az állványhoz.



**A szerelőfurat felhasználásával háromlábú állványhoz is rögzítheti a hálózati kamerát.**

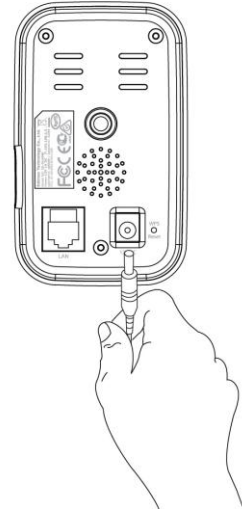


## II-2. Kamera

Kövesse az alábbi útmutatásokat annak ellenőrzése végett, hogy a kamerát megfelelően csatlakoztatta-e és az készen áll-e a beállításra.

**1.** Csatlakoztassa a tápadaptert a hálózati kamera tápbemenetéhez és a hálózati aljzathoz a jobb oldali képen látható módon.

**2.** Várja meg, amíg a kamera bekapcsolódik. Amikor a kamera kész, az áramellátást jelző **zöld LED lassan fog villogni**. Lásd a **III. fejezetet**. **A kamera beállítása** hálózati kameráját az ingyenes EdiView okostelefonos alkalmazás használatával állítsa be.



***Ha a kamerát Wi-Fi helyett Ethernet kábellel szeretné beállítani, nézze át a felhasználói kézikönyvet.***

## III. A kamera beállítása

---

Hálózati kamerája néhány perc alatt beállítható és használatra előkészíthető. Kövesse a következő fejezet útmutatásait, hogy kameráját az ingyenes EdiView alkalmazással Androidra vagy iPhone-ra telepítse.

Ezt követően a webes felületen keresztül tekintheti meg a kamera élőképét, illetve konfigurálhatja a kamera beállításait szükség szerint (segítséget a felhasználói kézikönyvben talál).

Valamint láthatja a kamera élőképét is bármilyen internet kapcsolat és böngésző segítségével, a felhőazonosító használatával (lásd itt:III-3.).

Folytathatja ezt is: **III-2. WPS** alternatív módszer ahhoz, hogy hálózati kameráját a vezeték nélküli hálózathoz csatlakoztathassa.

### III-1. EdiView alkalmazás

Az ingyenes EdiView okostelefonos alkalmazással állíthatja be kamerájának Wi-Fi kapcsolódását, és távoli helyről is figyelemmel kísérheti a kamerát bármilyen internet kapcsolaton keresztül.



***Ha a kamerát Wi-Fi helyett Ethernet kábellel szeretné beállítani, nézze át a felhasználói kézikönyvet.***

#### III-1-1. Android

**1.** Keresse meg a Google Play-ben az „EdiView II” elemet, majd töltsse le és telepítse az EdiView II alkalmazást.



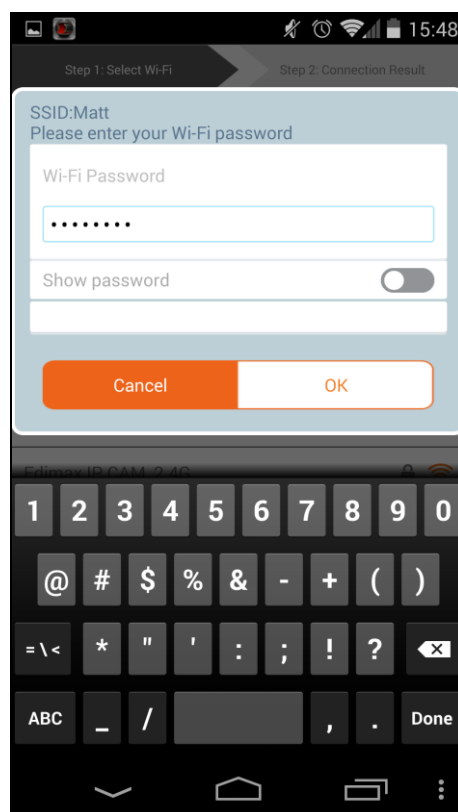
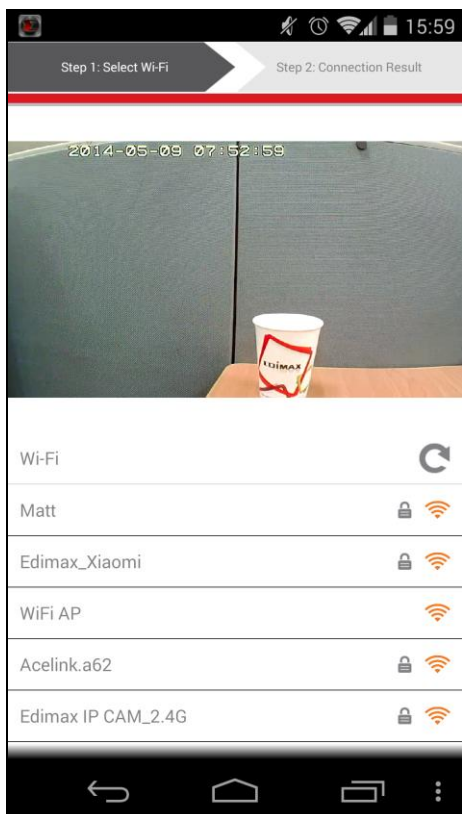

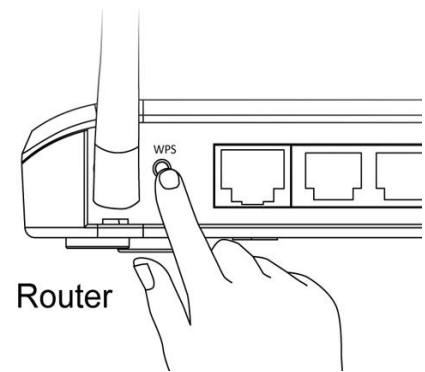
## III-2. WPS (Wi-Fi védett beállítás)

A WPS gombbal gyorsan és könnyedén létrehozható a biztonságos vezeték nélküli kapcsolat hálózati kamerája és vezeték nélküli routere/hozzáférési pontja között.

1. A WPS funkció aktiválásához nyomja meg és tartsa nyomva a megadott ideig a **vezeték nélküli routerén/hozzáférési pontján** található WPS gombot.



**A WPS gombnak a funkció aktiválásához szükséges nyomvatartási idejét illetően tekintse meg a vezeték nélküli router/hozzáférési pont felhasználói kézikönyvét.**

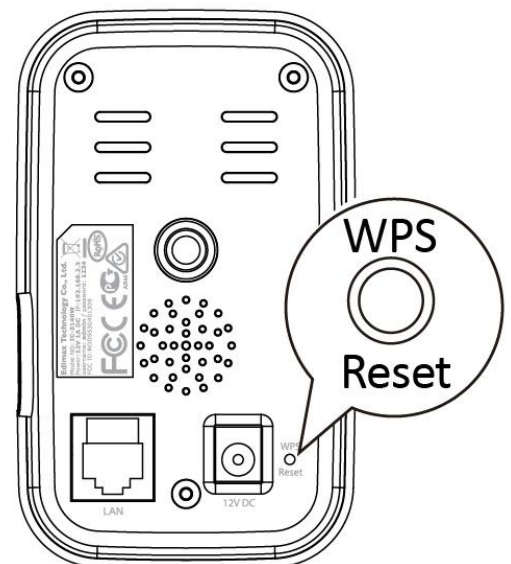


2. Ezt követően két percen belül nyomja meg és tartsa nyomva 2-5 másodpercig a hálózati kamerán található WPS/Reset gombot a WPS funkció aktiválásához. A **zöld** LAN LED **lassan villog**, jelezve, hogy a WPS aktív.

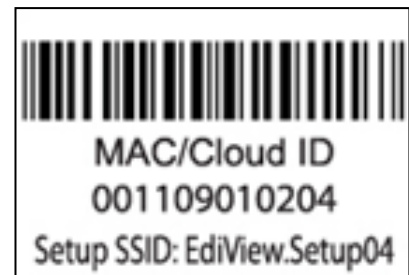
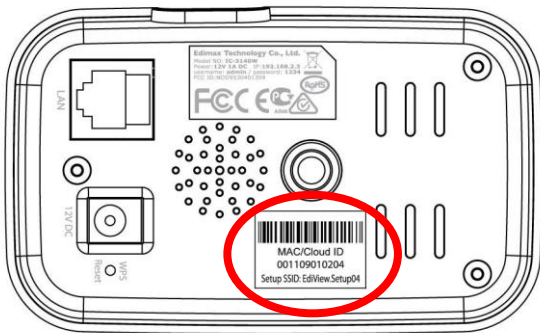
### III-3. Myedimax.com

Hálózati kamerájának Myedimax.com felhőazonosítója segítségével távoli helyről is figyelemmel kísérheti kamerája élőképet bármilyen aktív internetkapcsolattal rendelkező böngészőről. A funkció csak akkor működik, ha az áramellátást jelző **zöld LED világít**.

(Some other Free Software Foundation software is covered by the GNU Lesser General Public License instead.) You can apply it to your programs, too.
